WHERE TO GO AND WHAT TO DO IN EVENT OF A NUCLEAR ATTACK

You and your family need to know WHERE TO GO and WHAT TO DO in event of a nuclear attack on the United States. The following instructions are intended to provide you with this essential information. These instructions are based on the best possible use of the fallout protection now available in Scurry County.

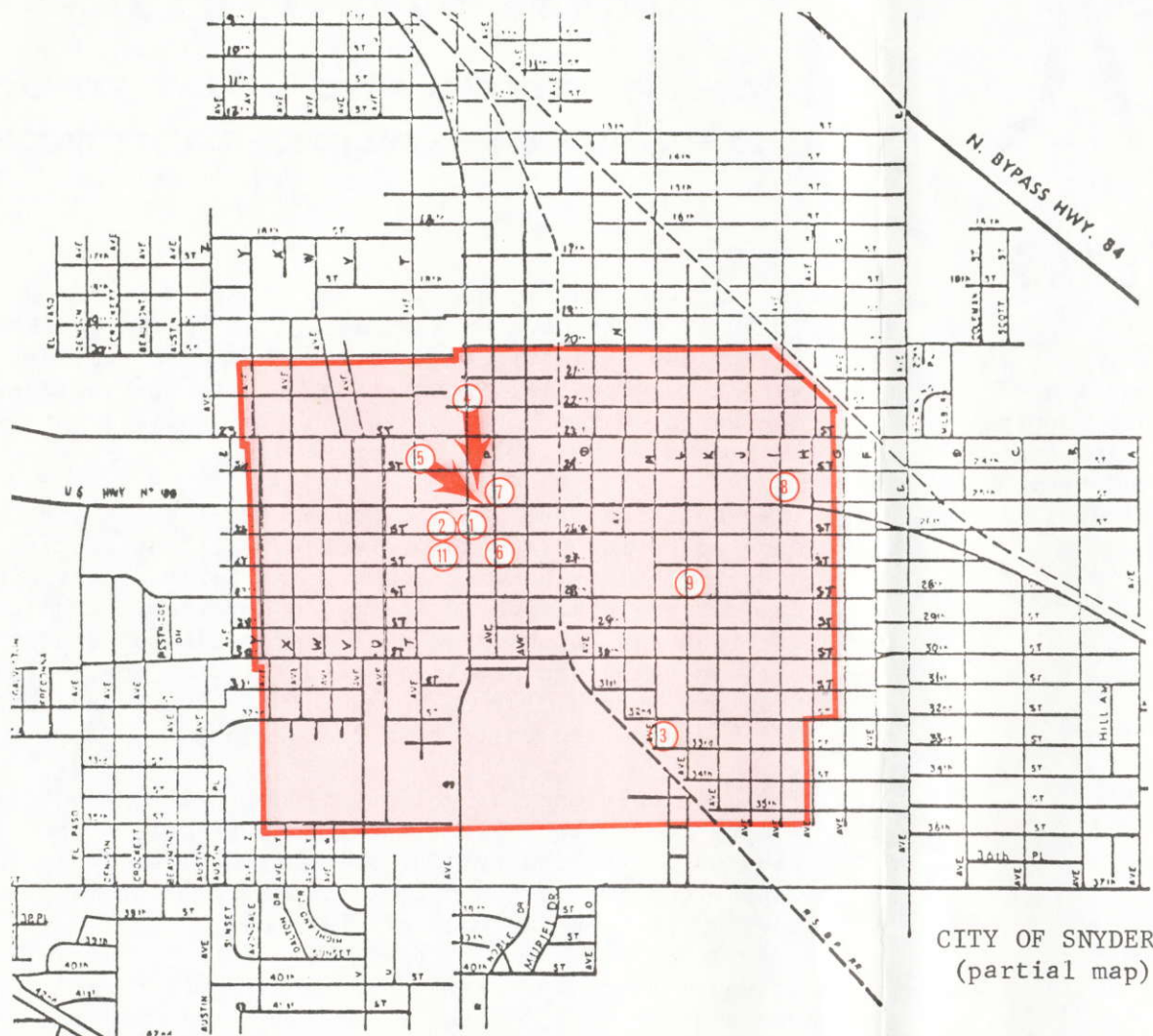
The radiation from fallout can be fatal to living things exposed to it. You can protect yourself by getting heavy materials between you and the fallout particles. Fallout could arrive in Scurry County within 60 minutes after an explosion on or near a probable selected target. Certain buildings have been identified as public fallout shelters in the City of Snyder. Some are marked with black and yellow fallout shelter signs.

There is only enough public fallout shelter space in Scurry County to shelter about 15 per cent of the population of the county. All of this shelter is in the City of Snyder in the buildings shown on the map and Shelter List on the back of this sheet.

If you live or work in an area where public shelter is not available, or if you choose to remain at home, you should go to the best protected part of the building. The enclosed handbook, "IN TIME OF EMERGENCY", gives detailed instructions on how to improvise shelter.

The warning to take shelter is a 3 to 5 minute wavering tone from sirens. Take your battery powered radio with you because it will be the primary means of keeping you informed.

The public fallout shelter in Scurry County will hold approximately the number of persons living in the shaded area shown on the map. Since the shelter facilities would be filled by those arriving first at the shelters, persons living outside the shaded area probably would not arrive in time to be sheltered.

The location and numbers of public shelter facilities are shown by a circle on the map. The number inside the circle is the number used to identify that shelter on the Shelter List. The Shelter List also identifies the building by name and address.

Shelter number 10, the Snyder High School Gym has a limited number of fallout shelter spaces. These spaces will be utilized on a first-come, first-served basis.
